四、招生學系及名額 Academic Programs and Admission Quotas

※錄取國際專修部學位先修生於第一年限修讀華語課程,學期間每週20小時,全 學年共修讀720小時,第一年修業期滿前須達華語文能力測驗(TOCFL)聽力與閱 讀測驗基礎級A2標準後,進入原錄取之學系自大一起修習,並於升大二前達到 華語文能力測驗(TOCFL)聽力與閱讀測驗進階級B1標準。

International students admitted to the International Foundation program are required to take Chinese language courses during their first year, with 20 hours per week, totaling 720 hours for the full academic year. Before the end of the first year, students must achieve **Level A2 standard** in the Test of Chinese as a Foreign Language (TOCFL) for listening and reading. After that, they can proceed to their originally admitted department/program starting from the first year of undergraduate studies. Before advancing to the second year of undergraduate studies, students must achieve **Level B1 standard** in the TOCFL listening and reading test.

Students in the International Foundation Studies program who fail to achieve the Level A2 standard in the TOCFL during their study period will be subject to dismissal according to the regulations.

During the study period in the International Foundation Program, students are NOT allowed to transfer to other departments or other schools.

※學生於正式修讀學士班課程一年後,方得於製造業、營造業、農業、長期照顧、 服務業及電子商務業等相關系所申請轉系或轉學。

After one year of formal study in the bachelor's program, students are allowed to apply for a transfer to academic departments in manufacturing, construction, agriculture, longterm care, service, and the e-commerce industry within the university or other universities. ※ 國際專修部修業規範請參考附錄3【中華大學國際專修部修業辦法】。

Those holding a visa other than a student visa in Taiwan must apply for a visa change at the Bureau of Consular Affairs, Ministry of Foreign Affairs. (Please note that the acceptance letter does not guarantee the issuance of a student visa.)

International students are allowed to apply for pre-study Chinese language courses in the International Foundation Program only once. In case of an interruption due to special circumstances, they may apply once more with the approval of the Ministry of Education

 凡報考資格不合或繳交之申請資料,經查如有偽造、假冒、不實者,應負法 律責任。一經發現本校將採下列方式處理

Applicants who do not meet the eligibility requirements or who submit false, forged, or inaccurate application materials shall be held legally responsible. Once discovered, CHU will take the following actions:

(1). 報名後查覺者,取消報名資格。

If discovered after application submission: The application qualification will be cancelled.

(2). 錄取後未註冊前查覺者,取消其錄取資格。

If discovered after acceptance but before registration: The acceptance will be revoked.

(3). 註冊入學後查覺者,開除學籍,並應負法律責任且不發給與修業有關之任何 證明文件。

If discovered after registration and enrollment: The student will be expelled, held legally responsible, and not issued any documents related to their studies.

(4). 畢業後始查覺者,除依法追繳其學位證書外,並公告撤銷其畢業資格,情節 重大者函送司法單位審理。

If discovered after graduation: In addition to legally revoking the degree certificate, the graduation qualification will be publicly annulled. In serious cases, the matter will be referred to judicial authorities for review.

(5). 若有特別要求相關資料或文件,將另行通知。

If any special requirements for related materials or documents are needed, a separate notification will be issued.

### 肆、獎學金申請資訊 Information for Scholarship

# 114 學年度秋季班學生獎學金 The scholarship for the fall semester of the 2025 academic year

一、113學年度第2學期起入學之學生。於國際專修部就讀期間第1學期免繳學雜費,第2
 學期繳交學雜費45,121元,第3學期進入學系後則依各系收費標準繳交學雜費。

For students enrolling from the Spring semester of the 2024 academic year onward: their tuition and fees are exempted for the very semester during their study in the International Foundation Program. In their second (Fall) semester, they pay 45,121 NTD for tuition and fees. From the third semester, after entering their chosen department, they will pay tuition and fees according to the standard rates of their respective departments.

二、學生於就讀期間,當學期出席率達 90%以上及學業成績平均 70 分以上,下學期學雜費 得減免 20%。符合資格之學生,每學期末由國際專修部學務組公告周知。

During their period of study, students who achieve an attendance rate of 90% or higher and maintain an average academic score of 70 points or above in the current semester will be eligible for a 20% reduction in tuition and miscellaneous fees for the following semester. Students who meet these qualifications will be notified by the Student Affairs Division of the International Foundation Program at the end of each semester.

三、學生於進入學系升大二前通過華語文能力測驗(TOCFL)之聽力與閱讀測驗進階級(B1)以 上,得申請 5,000 元獎學金,符合資格之學生須於第 5 學期開學日十五天前,且完成註冊手 續後,檢附相關華語能力測驗之相關證明,向國際專修部學務組提出申請,逾時視同放棄, 不得提出異議。

If a student passes the B1 level or above on the TOCFL Listening and Reading Test before advancing to the second year of their study in the department, they can apply for a 5,000 NTD

scholarship after the completion of their registration. Eligible students must submit their application to the Office of Student Affairs in the International Foundation Program, along with their Chinese language proficiency test certificates, within fifteen days before the start of their 5th semester. Late applications will be considered as forfeiting this scholarship opportunity, and no objections will be accepted.

#### 伍、申訴辦法 The Appeal Process

一、考生如對招生事宜認為有損益其權益情形時,得於放榜後一星期內,以書面向本校 國際專修部提出申訴。

Applicants who believe that admission matters affect their rights may submit an appeal application to the Office of the International Foundation Program within one week of the admission notification date

二、申訴案件以考生本人為當事人,不受理其他人申訴。

In the case of appeals, the applicants themselves are the parties. Other applications on behalf of appellants are not acceptable.

三、考生申訴書應詳載考生姓名、報考系所、通訊地址、聯絡電話、日期、申訴之事實 及理由、希望獲得之補救及檢附有關文件或證據。

The appeal application should include the applicant's name, the department applied for, mailing address, phone number, date, the facts and reasons for the appeal, the expected remedial measures, and any related documents or evidence.

四、考生申訴案如有下列情形者不予受理:

The applicant's appeal won't be accepted if there are some cases in the following status:

1. 招生有關法令或招生簡章已有明確規範者。

Those that have been listed on the related regulations or on the admission/transfer handbook.

2. 逾申訴期限。

Overdue the application deadline.

五、申訴以一次為限,申訴處理結果由國際暨兩岸事務處於一個月內函覆申訴人。

The appeal application may only be filed once. The Office of International and Cross-Strait Affairs will reply to the applicant with the results of the appeal within one month.

## **Standards for the Recognition of Equivalent Educational Levels for University Admission (extract)**

第一條:本標準依大學法第二十三條第四項規定訂定之。

Article 1: These standards are enacted pursuant to the provisions of Article 23, Paragraph 4 of the University Act.

**第二條**:具下列資格之一者,得以同等學力報考大學學士班(不包括二年制學士班)一年級新生入學考試:

一、高級中等學校及進修學校肄業學生有下列情形之一:

(一)僅未修習規定修業年限最後一年,因故休學、退學或重讀二年以上,持有學校核發之歷年成績單,或附歷年成績單之修業證明書、轉學證明書或休學證明書。

(二)修滿規定修業年限最後一年之上學期,因故休學或退學一年以上,持有學校核發之歷年成績單,或附歷年成績單之修業證明書、轉學證明書或休學證明書。

(三)修滿規定年限後,因故未能畢業,持有學校核發之歷年成績單,或附歷年成績單 之修業證明書、轉學證明書或休學證明書。

二、五年制專科學校及進修學校肄業學生有下列情形之一:

(一)修滿三年級下學期後,因故休學或退學一年以上,持有修業證明書、轉學證明書 或休學證明書,並檢附歷年成績單。

(二)修讀四年級或五年級期間,因故休學或退學,或修滿規定年限,因故未能畢業, 持有修業證明書、轉學證明書或休學證明書,並檢附歷年成績單。

三、依藝術教育法實施一貫制學制肄業學生,持有修業證明者,依其修業情形屬高級 中等學校或五年制專科學校,準用前二款規定。

四、高級中等學校及職業進修(補習)學校或實用技能學程(班)三年級(延教班)結業,持 有修(結)業證明書。

五、自學進修學力鑑定考試通過,持有普通型高級中等學校、技術型高級中等學校或 專科學校畢業程度學力鑑定通過證書。

六、知識青年士兵學力鑑別考試及格,持有高中程度及格證明書。

七、國軍退除役官兵學力鑑別考試及格,持有高中程度及格證明書。

八、軍中隨營補習教育經考試及格,持有高中學力證明書。

九、下列國家考試及格,持有及格證書:

(一) 公務人員高等考試、普通考試或一等、二等、三等、四等特種考試及格。

(二)專門職業及技術人員高等考試、普通考試或相當等級之特種考試及格。

十、持大陸高級中等學校肄業文憑,符合大陸地區學歷採認辦法規定,並有第一款所 列情形之一。

十一、技能檢定合格,有下列資格之一,持有證書及證明文件:

(一)取得丙級技術士證或相當於丙級之單一級技術士證後,從事相關工作經驗五年以上。

(二)取得乙級技術士證或相當於乙級之單一級技術士證後,從事相關工作經驗二年以上。

(三) 取得甲級技術士證或相當於甲級之單一級技術士證。

十二、年滿二十二歲,且修習下列不同科目課程累計達四十學分以上,持有學分證明:
 (一)專科以上學校推廣教育學分班課程。

(二) 教育部認可之非正規教育課程。

(三) 空中大學選修生選修課程(不包括推廣教育課程)。

(四) 職業訓練機構開設經教育部認可之專科以上教育階段職業繼續教育學分課程。

(五)專科以上學校職業繼續教育學分課程。

十三、年滿十八歲,且修習下列不同科目課程累計達一百五十學分以上,持有學分證 明:

(一) 職業訓練機構開設經學校主管機關認可之高級中等教育階段職業繼續教育學分課程。

(二) 高級中等學校職業繼續教育學分課程。

十四、空中大學選修生,修畢四十學分以上(不包括推廣教育課程),成績及格,持有 學分證明書。

十五、具有下列非學校型態實驗教育資格之一:

(一) 符合高級中等以下教育階段非學校型態實驗教育實施條例第三十條第二項規定。

(二)參與高級中等教育階段非學校型態實驗教育一年六個月以上,且與就讀五年制專 科學校合計三年以上。

Article 2: A person who meets any of the following eligibility criteria is considered to have adequate academic ability and may take the entrance examination for university bachelor's degree programs (excluding two-year bachelor's degree programs):

1. The student has not completed senior secondary school or a college of continuingeducation program but is in one of the following categories:

(1) The student completed all but the final year of the prescribed program but for some reason took leave or withdrew from their studies, or had to repeat a gradefor two years or more, and is able to provide a transcript of their results for all academic years that was issued by the school or college, or is able to provide a certificate of attendance, a transfer certificate, or a leave from studies certificate, each with such a transcript attached.

(2) The student completed the first semester of the final year of the prescribed program but for some reason took leave or withdrew from their studies for oneyear or more and is able to provide a transcript of their results for all academicyears that was issued by the school or college, or is able to provide a certificate of attendance, transfer certificate, or leave from studies certificate, each with such a transcript attached; or

(3) The student completed the prescribed program but, for some reason, was unable to graduate and has a school-issued transcript of their results for all academic years or is able to provide a certificate of attendance, transfer certificate, or leave from studies certificate, each with such a transcript attached.

2. The student has not completed a five-year junior college or college of continuingeducation program but is in one of the following categories:

(1) The student completed the second semester of the third year of their course butfor some reason took leave or withdrew from their studies for one year or more, and is able to provide a certificate of attendance, transfer certificate, or a leave from studies certificate, each with a transcript of their results for all academic years attached; or

(2) The student for some reason took leave or withdrew from their studies during their fourth or fifth year of study, or completed the prescribed program but forsome reason was unable to graduate, and is able to provide a certificate of attendance, transfer certificate, or a leave from studies certificate, each with a transcript of their results for all academic years attached.

3. For a student who undertook but did not complete a comprehensive educational program implemented in accordance with the Arts Education Act but is able to provide a certificate of attendance, one of the two preceding subparagraphs applies, mutatis mutandis, depending on whether they undertook a senior secondary schoolor five-year junior college program.

4. The student completed three years of a senior secondary school and vocational continuing (supplementary) education, or practical skills (extension education class) program and is able to provide a course completion certificate.

5. The student passed the Self-study Academic Ability Assessment Examination and able to provide a certificate attesting that their academic ability is equivalent to that of a graduate of a general senior high school, skills-based senior high school, or junior college.

6. The student passed the Academic Achievement Assessment Examination for educated young soldiers and is able to provide a certificate attesting that their academic ability is equivalent to senior secondary school level.

7. The student passed the Academic Achievement Assessment Examination for veterans and is able to provide a certificate attesting that their academic ability isequivalent to senior secondary school level.

8. The student passed a supplementary education for active military service personnel examination and is able to provide a certificate attesting that theiracademic ability is equivalent to senior secondary school level.

9. The student passed any of the following national examinations and has been awarded a certificate for the examination(s) which they have passed:

(1) Senior Civil Service Examination, Ordinary Level Civil Service Examination; or Level One, Level Two, Level Three, or Level Four Special Civil Service Examination;

(2) Senior Professional and Technical Personnel Examination, Ordinary Level Professional and Technical Personnel Examination; or a Special Examination of an equivalent level.

10. The student is able to provide a document from a senior secondary school inMainland China certifying that they have not yet completed the program and satisfies the provisions of the Regulations Regarding the Assessment and Recognition of Academic Credentials from the Mainland Area, and their circumstances are one of those stipulated in Subparagraph 1.

11. The student is able to provide a certificate and documentary evidence attesting that they have passed one of the following professional skill assessment tests:

(1) The student has been awarded a Level C certified technician's certificate, or asingle-class certified technician's certificate equivalent to Level C, and since then has had five or more years of related practical work experience; or

(2) The student has been awarded a Level B certified technician's certificate, orsingle-class certified technician's certificate equivalent to Level B, and sincethen has had two or more years of related practical work experience; or

(3) The person has been awarded a Level A certified technician's certificate, orsingle-class certified technician's certificate equivalent to Level A.

12. The student is aged at least 22 and is able to provide documentary evidence that they have accumulated a total of 40 or more credits studying different courses of the sort listed below:

(1) Continuing education credit courses offered by a junior college, tertiarycollege, or university; or

(2) Non-formal education programs accredited by the Ministry of Education; or

(3) Non-degree programs (not including continuing education programs) for non-degree students offered by open universities; or

(4) Vocational continuing education credit courses at the junior college, tertiary college, or university education level offered by a vocational training institute that have been accredited by the Ministry of Education; or

(5) Vocational continuing education credit courses offered by a junior college, tertiary college, or university.

13. The student is aged at least 18 and is able to provide documentary evidence that they have accumulated a total of 150 or more credits studying different courses of the sort listed below:

(1) Vocational continuing education credit courses at the senior secondary education level offered by a vocational training institute that have been accredited by the competent school authority; or

(2) Vocational continuing education credit courses offered by a senior secondaryschool.

14. The student is able to provide documentary evidence that they have earned 40 ormore credits studying as a non-degree student at an open university (not including continuing education programs) and had satisfactory results.

七、第五項、前項、第十項及第十二項所定國外或香港、澳門學歷(力)證件、成績單 或相關證明文件,應經我國駐外機構,或行政院在香港、澳門設立或指定機構驗證。

八、臺灣地區與大陸地區人民關係條例中華民國八十一年九月十八日公布生效後,臺 灣地區人民、經許可進入臺灣地區團聚、依親居留、長期居留或定居之大陸地區人民、外 國人、香港或澳門居民,持大陸地區專科以上學校畢(肄)業學歷,且符合下列各款資格者, 得準用第二條第二款、第三條第一項第一款至第四款、第五條第一款至第四款及前條第一 項第一款與第二款規定辦理:

(一) 其畢(肄)業學校經教育部列入認可名冊,且無大陸地區學歷採認辦法第八條不予採認之情形。

(二) 其入學資格、修業年限及修習課程,均與臺灣地區同級同類學校規定相當,並經 各大學招生委員會審議後認定為相當臺灣地區同級同類學校修業年級。

九、持大陸地區專科以上學校畢(肄)業學歷,符合大陸地區學歷採認辦法規定者,得 準用第四條第一項第一款至第三款、第二項及第三項第一款規定辦理。

十、持國外或香港、澳門學士學位,其畢業學校經教育部列入參考名冊或為當地國政 府權責機關或專業評鑑團體所認可,且入學資格、修業年限及修習課程均與我國同級同類 學校規定相當,並經大學校級或聯合招生委員會審議後認定為相當國內同級同類學校修業 年級者,或持大陸地區學士學位,符合大陸地區學歷採認辦法規定者,修習第四條第三項 第二款之不同科目課程達二十學分以上,持有學分證明,得報考學士後學士班轉學考試, 轉入二年級。 十一、持前三項大陸地區專科以上學校畢(肄)業學歷報考者,其相關學歷證件及成績證明,應準用大陸地區學歷採認辦法第四條規定辦理。

十二、持國外或香港、澳門相當於高級中等學校程度成績單、學歷(力)證件,及經當 地政府教育主管機關證明得於當地報考大學之證明文件,並經大學校級或聯合招生委員 會審議通過者,得以同等學力報考大學學士班(不包括二年制學士班)一年級新生入學考試。 但大學得視其於國外或香港、澳門之修業情形,增加其畢業應修學分或延長其修業年限。

Article 9: The provisions of Article 2, Subparagraph 1 may also be applied, mutatis mutandis, for a person who received secondary school education in a foreign country, or HongKong, or Macao and satisfies the provisions of the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education, or those of the Regulations Regarding the Assessment and Recognition of Academic Credentials for the Hong Kong and Macao Areas.

A student who graduated in a foreign country, Hong Kong, or Macao from a seniorsecondary school whose graduating year is academically equivalent to the second grade of a senior secondary school in Taiwan of a comparable academic level and nature is considered to have adequate academic ability and may take the entrance examination for new students for university bachelor's degree programs. However, the university shall increase the number of credits required for such students to graduate or extend the prescribed length of their program.

The provisions of Article 2, Subparagraph 1 may also apply, mutatis mutandis, to astudent who attended a school in a foreign country, Hong Kong, or Macao of a comparable academic level and nature to senior secondary schools in Taiwan, but which requires more years of study to complete than senior secondary schools in Taiwan do, and who did not complete their secondary studies there but completed grades/years of study equivalent to particular grades/years of the prescribed senior secondary school program in Taiwan.

The provisions of Paragraph 1, Subparagraphs 3 and 4 of the preceding article may also apply, mutatis mutandis, to a person who was awarded a bachelor's degree in aforeign country, Hong Kong, or Macao and satisfies the provisions of the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education, or those of the Regulations Regarding the Assessment and Recognition of Academic Credentials for the Hong Kong and Macao Areas.

The provisions of Article 2, Subparagraph 2; Article 3, Paragraph 1, Subparagraphs 1 to 4; Article 4, Paragraph 1, Subparagraphs 1 to 3, Paragraph 2, and Paragraph 3, Subparagraph 1; Article 5, Subparagraphs 1 to 4; and Paragraph 1, Subparagraphs 1 and 2 of the preceding article may also apply, mutatis mutandis, for a student with anacademic record of graduating from (or not yet completing a program at) a junior college or higher level educational institution in a foreign country, Hong Kong, or Macao which is included in the Ministry of Education List of Recognized Higher Education Institutions or which has been accredited by an organization authorized by the government where it is located, or by a professional accreditation body, if the educational institution's enrollment eligibility criteria, length of prescribed programs, and curricula are all equivalent to those specified in regulations governingeducational institutions of the same level and nature in Taiwan, and the educational standard of its students has been reviewed by the admission committee of a particular university or by a joint admission committee and been determined to be equivalent to that provided by an educational institution of the same level and nature Taiwan.

A person who was awarded an associate degree and was issued a transcript of their results for all academic years, or was issued an advanced diploma and a transcript of their results for all academic years by such an educational institution in Hong Kong or Macao as referred to in the previous paragraph, is considered to have adequate academic ability and may take the entrance examination for new students for the firstyear of two-year bachelor's degree programs at a university of science and technology, or an institute of technology.

The academic credentials, records of academic performance (ability), and transcriptsof results, or related documentary evidence issued in a foreign country, Hong Kong, or Macao referred to in Paragraph 5, the previous paragraph, Paragraph 10, and/or Paragraph 12 shall each be examined and verified by an overseas representative office of the ROC, or by an agency in Hong Kong or Macao established or designated by the ROC Executive Yuan.

Since the Act Governing Relations between Peoples of Taiwan Area and Mainland Area was promulgated and took effect on September 18, 1992, the provisions of Article 2, Subparagraph 2; Article 3, Paragraph 1, Subparagraphs 1 to 4; Article 5, Subparagraphs 1 to 4; and of Paragraph 1, Subparagraphs 1 and 2 of the preceding Article may also be applied, mutatis mutandis, to people from the Taiwan Area, and people from the Mainland China area, foreigners, or residents of Hong Kong or Macao who have been given permission to enter Taiwan for family reunification, asrelative-sponsored residents, for long-term residence, or settlement who have an academic record of graduating from (or did not complete the program at) a junior college or higher level educational institution in Mainland China which meets thefollowing criteria:

1. The educational institution is included in the Ministry of Education List of Recognized Higher Education Institutions in Mainland China and does not have any of the precluding characteristics set out in the provisions of Article 8 of the Regulations Regarding the Assessment and Recognition of Academic Credentialsfrom the Mainland Area.

2. The educational institution's enrollment eligibility criteria, length of prescribed programs, and curricula are all equivalent to those specified in regulations governing educational institutions of the same level and nature in Taiwan, and the educational program(s) provided must have been reviewed and determined by theAdmission Committee of a university in Taiwan to be equivalent to those provided by an educational institution of the same level and nature in Taiwan.

The provisions of Article 4, Paragraph 1, Subparagraphs 1 to 3; Paragraph 2; and Paragraph 3, Subparagraph 1 may also be applied, mutatis mutandis, to a person whograduated from (or did not complete the program at) a junior college or higher level educational institution in the Mainland China area and satisfies the provisions of the Regulations Regarding the Assessment and Recognition of Academic Credentials from the Mainland Area.

If a person has a bachelor's degree awarded in a foreign country, Hong Kong, or Macao and has academic records of graduating from (or not yet completing a program at) a higher educational institution in a foreign country, Hong Kong, or Macao which is included in the Ministry of Education List of Recognized Higher Education Institutions, or which has been accredited by an organization authorized by the government where it is located, or by a professional accreditation body, and ifthat educational institution's enrollment eligibility criteria, length of prescribed programs, and curricula are all equivalent to those specified in regulations governingeducational institutions of the same level and nature in Taiwan, and the educational standard of its students has been reviewed by the admission committee of a particular university

or by a joint admission committee and been determined to be equivalent to that provided by an educational institution of the same level and naturein Taiwan; or if a person has a bachelor's degree awarded by a higher educational institution in the Mainland China Area and satisfies the provisions of the RegulationsRegarding the Assessment and Recognition of Academic Credentials from the Mainland Area, and if the person is able to provide documentary evidence that they have accumulated a total of 20 credits or more studying different courses of the sort listed in the provisions of Article 4, Paragraph 3, Subparagraph 2, then the person may take an examination to transfer into a post-baccalaureate bachelor's degree program, and if they are admitted they may transfer into the second-year of the program.

The provisions of Article 4 of the Regulations Regarding the Assessment and Recognition of Academic Credentials from the Mainland Area shall be applied, mutatis mutandis, regarding the academic credentials and records referred to in the preceding three paragraphs if a person who graduated from (or did not complete theprogram at) a junior college or higher - level educational institution in the Mainland China area wants to take a university entrance examination.

If a person is able to provide transcripts of their results, and records of academic performance (ability) issued in a foreign country, Hong Kong, or Macao indicating that they have received an education equivalent to completing secondary school andis also able to provide documentary evidence that was issued by the competent education authority of the government in that location that the person may take the local entrance examination for new students for university bachelor's degree programs, and that documentary evidence has been reviewed and endorsed by the admission committee of a particular university or by a joint admission committee, then the person may take the entrance examination for new students for university bachelor's degree programs.

However, the university may, after taking into consideration a person's academic performance in a foreign country, Hong Kong, or Macao, increase the number of credits required for such a student to graduate or extend the prescribed length of their program or extend the prescribed length of their program.

第十條 軍警校院學歷,依教育部核准比敘之規定辦理。

Article 10: For a student who has studied at a military or police college or academy, the relevant authorized MOE regulations governing comparative educational levels apply.

第十一條 本標準所定年數起迄計算方式,除下列情形者外,自規定起算日,計算至報 考當學年度註冊截止日為止:

一、離校或休學年數之計算:自歷年成績單、修業證明書、轉學證明書或休學證明書 所載最後修滿學期之末日,起算至報考當學年度註冊截止日為止。

二、專業訓練及從事相關工作年數之計算:以專業訓練或相關工作之證明上所載開始 日期,起算至報考當學年度註冊截止日為止。

Article 11: When some number of years is stipulated in these Standards, the period is calculated from the stipulated beginning date until the latest date on which students can enroll for the academic year for which the student took the entrance examination, with the exception of the two instances set out below:

1. To determine the number of years a person has discontinued or taken leave fromformal study, count from the end date of the last semester that the student completed, as recorded in the transcript of their results

for all academic years, certificate of attendance, or transfer certificate, until the latest date on which students can enroll for the academic year for which the student took the entrance examination.

2. To determine the number of years of professional training and related work: countfrom the starting date recorded on the professional training - related certificate or ona certificate attesting to the related work experience to the latest date on which students can enroll for the academic year for which the student took the entrance examination.

第十二條 本標準自發布日施行。

Article 12: These Standards shall take effect from the date of promulgation.

### 2. 外國學生來臺就學辦法[節錄]

# **Regulations Regarding International Students Undertaking Studies in Taiwan [Excerpts]**

中華民國一百十年一月二十二日

教育部臺教文(五)字第 1100003461B 號令修正發布第 2~6、8、12 條條文; 增訂第 27-1 條條文

第一條 本辦法依大學法第二十五條第三項、專科學校法第三十二條第一項、高級中等 教育法第四十一條第一項及國民教育法第六條第三項規定訂定之。

Article 1: These regulations are formulated in accordance with the provisions of Article 25, Paragraph 3 of the University Act, Article 32, Paragraph 1 of the Junior College Act, Article 41, Paragraph 1 of the Senior High School Education Act, and Article 6, Paragraph 3 of the Primary and Junior High School Act.

第二條

一.具外國國籍且未曾具有中華民國國籍,符合下列規定者,得依本辦法規定申請入學:

(一) 未曾以僑生身分在臺就學。

(二) 未於申請入學當學年度依僑生回國就學及輔導辦法經海外聯合招生委員會分發。

二. 具外國國籍並符合下列規定,且最近連續居留海外六年以上者,亦得依本辦法規 定申請入學。但擬就讀大學醫學、牙醫或中醫學系者,其連續居留年限為八年以上:

(一) 申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。

(二)申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可 喪失中華民國國籍之日起至申請時已滿八年。

(三) 前二款均應符合前項第一款及第二款規定。

三. 依教育合作協議,由外國政府、機構或學校遴薦來臺就學之外國國民,其自始未 曾在臺設有戶籍者,經主管教育行政機關核准,得不受前二項規定之限制。

四. 第二項所定六年、八年,以擬入學當學期起始日期(二月一日或八月一日)為終日計 算之。

五. 第二項所稱海外,指大陸地區、香港及澳門以外之國家或地區;所稱連續居留,指 外國學生每曆年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬 完整曆年者,以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。但符合 下列情形之一且具相關證明文件者,不在此限;其在國內停留期間,不併入海外居留期間 計算:

六. 具外國國籍並兼具中華民國國籍,且於本辦法中華民國一百年二月一日修正施行 前已提出申請喪失中華民國國籍者,得依原規定申請入學,不受第二項規定之限制。

Article 2: A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who meets the following requirements is permitted to apply for admission to an educational institution, in accordance with the provisions of these regulations:

1. The person has never undertaken studies in Taiwan as an overseas Chinese student.

2. The person has not been given a placement in the current academic year by the University Entrance Committee for Overseas Chinese Students in accordance with the Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan.

A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years is also permitted to apply for admission to an educational institution, in accordance with these regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

1. A person who at the time of their application also holds dual R.O.C. nationalityshall have never had household registration in Taiwan.

2. A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application.

3. A person referred to in either of the preceding two subparagraphs shall meet therequirements stipulated in subparagraph 1 and subparagraph 2 of the previous paragraph.

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval.

The periods of six years and eight years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

The term "overseas" used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau, the term "reside overseas continuously" means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

1. Attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;

 Spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;

3. Spent a total period of less than two years in Taiwan as an exchange student

4. Spent a total period of less than two years undertaking an internship that they cameto Taiwan to undertake with the approval of the designated central competent authority.

A person who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 01, 2011 amendment to these regulations may apply for

admission as an international studentin accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2.

第三條

一. 具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、 澳門或海外連續居留滿六年以上者,得依本辦法規定申請入學。但擬就讀大學醫學、牙醫 或中醫學系者,其連續居留年限為八年以上。

二. 前項所稱連續居留,指每曆年在國內停留期間,合計未逾一百二十日。但符合前 條第五項第一款至第四款所列情形之一且具相關證明文件者,不在此限;其在國內停留 期間,不併入前項連續居留期間計算。

三. 曾為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留海外六年 以上者,得依本辦法規定申請入學。但擬就讀大學醫學、牙醫或中醫學系者,其連續居 留年限為八年以上。

四. 前項所稱連續居留,指每曆年在國內停留期間,合計未逾一百二十日。但符合前 條第五項第一款至第四款所列情形之一且具相關證明文件者,不在此限;其在國內停留 期間,不併入海外連續居留期間計算。

五. 第一項及第三項所定六年、八年,以擬入學當學期起始日期(二月一日或八月一日) 為終日計算之。

六. 第一項至第四項所定海外,準用前條第五項規定。

Article 3: An applicant of foreign nationality who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

The term "resided [...] continuously" in the preceding paragraph means that a persondid not spend more than a total of 120 days in Taiwan in each calendar year.

However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period of continuous residence referred to in the previous paragraph.

A person who was formerly from the Mainland Area and who has foreign nationality and has never had household registration in Taiwan and who, at the time of their application, has resided overseas continuously for at least six years may apply for admission to an educational institution, in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years.

The term "resided [...] continuously" in the preceding paragraph means that a persondid not spend more than a total of 120 days in Taiwan in each calendar year.

However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period that they resided continuously overseas referred to in the previous paragraph.

The periods of six years and eight years stipulated in Paragraph 1 and in Paragraph 3 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

The definition of "overseas" given in Paragraph 5 of the previous article also applies, mutatis mutandis, to Paragraphs 1 to 4.

第四條

 一.外國學生依前二條規定申請來臺就學,以一次為限;其繼續在臺就學者,入學方 式應與我國內一般學生相同。但下列情形,不在此限:

(一)於完成申請就學學校學程後,申請碩士班以上學程,逕依各校規定辦理。

(二)外國學生申請來臺就讀學士班以下學程,在國內停留未滿一年,因故退學或喪失 學籍,得重新申請來臺就學,並以一次為限。

二. 外國學生經入學學校以操行或學業成績不及格、違反法令或校規情節嚴重致遭退學 或喪失學籍者,不得再依前項規定申請入學。

Article 4: An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous articles is limited to only applying once. If a student wants to continue studying in Taiwan, their application shall be handled in the same manner as the admission procedures for domestic students. However, this requirement does not apply to an international student in either of the following circumstances:

1. If an international student is applying for admission to a master's degree or higher level program after completing the course of study at the educational institution to which they originally applied, the university to which the student is now applying shall handle the application in accordance with its regulations;

2. If an international student applied to come to Taiwan to undertake a bachelor's degree or lower level program in Taiwan and, after coming to Taiwan, stayed for less than one year for some reason and then discontinued their studies or forfeited their student status, that student may lodge another application to come to Taiwan to study, but only one such re-application is permitted.

If an educational institution in Taiwan where an international student was studying considers that their conduct or academic performance was unsatisfactory, or if the student seriously violated any ordinances or the regulations of the educational institution and the circumstances were serious and, as a result, in accordance with the provisions of its regulations governing student awards and penalties had to discontinue their studies or forfeited their status as a registered student, the student is not permitted to re-apply to study in Taiwan on the basis of the provisions of the previous paragraph.

第五條

一.大學及專科學校二年制(以下簡稱大專校院)實際招收入學之外國學生,其名額以本 部核定該校前一學年度招生名額外加百分之十為原則,並應併入當學年度招生總名額報本 部核定;申請招收外國學生名額超過前一學年度核定招生名額外加百分之十者,應併同提 出增量計畫(包括品質控管策略及配套措施)報本部核定。但國內大學與外國大學合作並經本 部專案核定之學位專班,不在此限。

二.專科學校五年制及高級中等以下學校實際招收入學之外國學生,其名額以各主管教 育行政機關核定該校前一學年度招生名額外加百分之十為限,並應併入當學年度招生總名 額報各主管教育行政機關核定。

三. 大專校院於前一學年度核定招生總名額內,有本國學生未招足情形者,得以外國學 生名額補足,並應報本部核定。

四. 第一項及第二項招生名額, 不包括未具正式學籍之外國學生。

Article 5: In principle, the actual number of places available for international students to be admitted to universities and two-year programs at junior colleges (hereunder referred to as "universities and tertiary colleges") is limited to an additional ten percent above the admission quota that was approved for the institution for the previous academic year by the Ministry of Education, and that number shall be incorporated into the total admission quota and reported to the Ministry of Education for approval. A university or junior college applying to recruit more than an additional ten percent shall submit a report of the planned increment (including an associated quality control strategy and supportive measures) to the Ministry of Education for approval. Degree programs offered by collaborating domestic and foreign universities that have been approved on a case - by - case basis by the Ministry of Education are not subject to this restriction.

The actual number of international students that may be admitted to a five-year program at a junior college, or to a senior secondary school, junior high school, or an elementary school is limited to an additional ten percent above the admission quota that was approved for the institution for the previous academic year that was approved by the competent education administrative authority, and that number shall be included in the total number of students admitted for that academic year and be reported to the competent education administrative authority for approval.

Universities and tertiary colleges may augment the number of places at their institution available to international students by the number of places that were available to local students within the admission quota that was approved for the institution for the previous academic year and shall first report such an increase to the Ministry of Education for approval.

The admission quotas referred to in Paragraph 1 and Paragraph 2 do not include international students who are not officially registered as a current student.

第六條 大專校院招收外國學生入學各年級,應擬訂公開招生規定報本部核定後,自行 訂定外國學生招生簡章,詳列招生學系、修業年限、招生名額、申請資格、甄選方式及 其他相關規定。

Article 6: A university or tertiary college that recruits and admits international students into any year of its programs shall formulate its own related admission regulations and make these public after they have been approved by the Ministry of Education, and formulate a set of international student admission guidelines that outline details of the degree programs that admit international students, the length of time in which each program must be completed, admission quotas, admission eligibility requirements, reviewing and screening methods, and any other related regulations.

第七條

一.申請入學大專校院之外國學生,應於各校院指定期間,檢附下列文件,逕向各該校
 院申請入學,經審查或甄試合格者,發給入學許可:

(一)入學申請表。

(二) 學歷證明文件:

1.大陸地區學歷:應依大陸地區學歷採認辦法規定辦理。

2.香港或澳門學歷:應依香港澳門學歷檢覈及採認辦法規定辦理。

3.其他地區學歷:

(1)海外臺灣學校及大陸地區臺商學校之學歷同我國同級學校學歷。

(2)前二目以外之國外地區學歷,應依大學辦理國外學歷採認辦法規定辦理。但設校或 分校於大陸地區之外國學校學歷,應經大陸地區公證處公證,並經行政院設立或指定之機 構或委託之民間團體驗證。

(三)足夠在臺就學之財力證明,或政府、大專校院或民間機構提供全額獎助學金之證明。

(四)申請學校所規定之其他文件。

二.各校審核外國學生之入學申請時,對前項第二款至第四款未經我國駐外機構、行政 院設立或指定之機構或委託之民間團體驗證之文件認定有疑義時,得要求經驗證;其業經 驗證者,得請求協助查證。

Article 7: International students applying for admission to a university or tertiary college shall submit the following documents and apply directly to the university or college during its designated application period, and applicants who pass the review or screening process will be issued an admission notice:

1. An enrollment application form

2. Academic credentials:

Academic credentials from the Mainland Area shall be handled in accordance with the provisions of the Regulations Regarding the Assessment and Recognition of Academic Credentials for Mainland Area.

Academic credentials from Hong Kong or Macao shall be handled in accordance with the provisions of the Regulations Governing the Examinationand Recognition of Educational Qualifications from Hong Kong and Macao.

Academic credentials issued by an overseas Taiwan school or a school for Taiwan business people in the Mainland Area shall be regarded as equivalent to academic credentials issued by an educational institution of the same level in Taiwan. Academic credentials from overseas other than those referred to in the preceding two items shall be handled in accordance with the provisions of the Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education. However, academic credentials issued by a campus or branch that a foreign educational institution has established in the Mainland Area shall be notarized by a notary public there and authenticated by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan. 3. Proof that the applicant has sufficient funds to cover living expenses while studying in Taiwan, or proof of a full scholarship or grant provided by a government, university, college, or private organization

4. Other documents required by the educational institution being applied to. When an educational institution reviews an international student's admission application, if any of the documents specified in Subparagraphs 2 and 4 of the preceding paragraph have not been authenticated by an overseas mission, or by an agency established or designated by the Executive Yuan, or by a private organization commissioned by the Executive Yuan, and the educational institution has any doubts about them, it may request authentication by an overseas agency. If documents that have already been authenticated raise any doubts, the educational institution may request examination of the documents.

第7-1 條 外國學生所繳入學證明文件有偽造、假借、塗改等情事,應撤銷錄取資格; 已註冊入學者,撤銷其學籍,且不發給任何相關學業證明;如畢業後始發現者,應由學 校撤銷其畢業資格並註銷其學位證書。

Article 7-1 An international student who submits any certificate or document as part of their application for admission to an educational institution that is found to be forged, fabricated, or that has been altered in some way shall have their enrollment eligibility revoked. If the student has already registered and begun classes, their registration as a current student shall be cancelled, and they will not be awarded any certification what soever regarding their related academic undertakings. If any such circumstances are first discovered after a student has already graduated, the educational institution shall revoke the former student's eligibility to graduate, shall require any degree already awarded to be returned, and shall rescind it.

第八條

一.外國學生已在臺完成學士以上學位,繼續申請入學碩士以上學程者,得檢具我國 各校院畢業證書及歷年成績證明文件,依第七條規定申請入學,不受第七條第一項第二 款規定之限制。

二.外國學生在我國就讀外國僑民學校或我國高級中等學校附設之雙語部(班)或私立高級中等學校外國課程部班畢業者,得持該等學校畢業證書及歷年成績證明文件,依第七條規定申請入學,不受第四條第一項及第七條第一項第二款規定之限制。

Article 8: An international student who has completed a bachelor's degree or a higher degree in Taiwan and is applying to be admitted to do a master's degree program or a higher degree may submit copies of their graduation certificate from a university or tertiary college in Taiwan and transcripts for each year of their studies and apply in accordance with the provisions of Article 7 and is not subject to the provisions of Article 7, Paragraph 1, Item 2.

An international student who has graduated from a school for international residents in Taiwan, or from a bilingual division (program) affiliated with a domestic senior secondary school, or from a program offering a foreign curriculum at a division of adomestic private senior secondary school may submit copies of their graduation certificate, and their transcripts for each year, and apply for admission in accordance with the provisions of Article 7 and is not subject to the provisions of Article 4, Paragraph 1, or the provisions of Article 7, Paragraph 1, Subparagraph 2.

第九條 招收外國學生之大專校院,應即時於本部指定之外國學生資料管理資訊系統, 登錄外國學生入學、轉學、休學、退學或變更、喪失學生身分等情事。

114 學年度國際專修部招生簡章

Article 9: A university or tertiary college that admits international students shall promptly register details of the following into the international student data management information system designated by the Ministry of Education: the international students admitted and registered, any transfer, deferral, or abandonment of studies, and any change to or loss of student status.

第十條 外國學生不得申請就讀我國大專校院所辦理回流教育之進修學士班、碩士在職 專班及其他僅於夜間、例假日授課之班別。但外國學生在臺已具有合法居留身分者或其 就讀之班別屬經本部專案核准之課程者,不在此限。

Article 10: An international student is not permitted to apply to study any recurrent or continuing education bachelor's degree program or in-service master's degree program, or any other program that is only taught in the evening or during vacations, at a university or tertiary college in Taiwan. However, an international student who already has legitimate resident status or who is undertaking a program approved on a case - by - case basis by the Ministry of Education is not subject to this restriction.

第十一條 大專校院、專科學校五年制、高級中等以下學校之外國學生註冊入學時,未 逾該學年第一學期修業期間三分之一者,於當學期入學;已逾該學年第一學期修業期間三 分之一者,於第二學期或下一學年註冊入學。但各主管教育行政機關另有規定者,不在此 限。

Article 11: An international student who reports to register at a university or tertiary college, a five-year program at a junior college, or a senior secondary school, junior high school, or an elementary school before it is already one-third of the way into the first semester of the current academic year shall be registered for the first semester. If it is already more than one-third of the way into the first semester, the international student shall register for the second semester or the next academic year. However, this restriction does not apply if each competent educational administrative authority has some provision that overrides it.

第十二條

一.大學外國學生於我國大學畢業後,經學校核轉本部許可在我國實習者,其外國學生
 身分最長得延長至畢業後一年。

二. 外國學生來臺就學後,其於就學期間許可在臺初設戶籍登記、戶籍遷入登記、歸化 或回復中華民國國籍者,喪失外國學生身分,應予退學。但入學方式與我國內一般學生相 同者,及依國籍法第四條第一項第一款至第三款申請歸化取得中華民國國籍者,不在此限。

三. 於我國大專校院就讀之外國學生轉學,由各大專校院自行訂定相關規定,並納入 招生規定報本部核定。但外國學生經入學學校以操行不及格或因刑事案件經判刑確定致 遭退學者,不得轉學進入大專校院就讀。

Article 12: An international student who, with Ministry of Education approval, is undertaking an internship after graduating from a university in Taiwan may have their international student status extended for up to one year after their graduation.

An international student who has been permitted to undertake initial household registration, resident registration, naturalization, or restoration of R.O.C nationality procedures during the course of their studies in Taiwan will forfeit their international student status and shall be dismissed by their educational institution. However, a student whose application was handled in the same manner as the admission procedures for

domestic students and who applies for naturalization to acquire the nationality of the ROC in accordance with Subparagraphs 1 to 3, Paragraph 1, and Article 4 of the Nationality Act is not subject to this requirement.

If an international student who studies at a university or tertiary college in Taiwan wants to transfer to another university or tertiary college. Each university or tertiary college shall formulate its own regulations regarding transfers of international students who study in a university or tertiary college in Taiwan, incorporate these into its admission regulations, and submit these to the Ministry of Education for approval. However, an international student who has been dismissed by the educational institution that admitted the student as a result of unsatisfactory conduct or of a conviction in criminal case proceedings is not permitted to transfer to another university or tertiary college.

第十三條

 一.大專校院在不影響正常教學情況下,得與外國學校簽訂教育合作協議,招收外國 交換學生;並得準用外國學生入學規定,酌收外國人士為選讀生。

二. 高級中等以下學校經各主管教育行政機關核准者,得招收外國學生來臺進行一年以 下之短期研習。

Article 13: A university or tertiary college may sign an education cooperation agreement with a foreign educational institution and recruit and admit international exchange students, provided that this does not affect normal teaching. A university or tertiary college may also apply, mutatis mutandis, its own international student admission regulations to accept suitable international students as non-degree students.

With approval from each competent education administrative authority, senior secondary schools, junior high schools, and elementary schools may recruit international students for short-term periods of study in Taiwan of one year or less.

第十四條 各級學校因國際學術合作計畫或其他特殊需求成立外國學生專班者,應依各 級學校總量發展規模與資源條件相關規定,經該管主管教育行政機關核轉本部核定。

Article 14: Educational institutions at all levels that establish programs exclusively for international students as part of an international academic cooperation program or to meet some other special need shall do so in accordance with the regulations governing the overall scale of and resources for the development of an educational institution at their level, and the competent education administrative authority willforward details of such programs for appraisal and approval by the Ministry of Education.

第十五條

一. 本部為獎勵就讀大專校院優秀外國學生,得設置或補助學校設置外國學生獎學金。

二. 大專校院為鼓勵外國學生來臺就學,得自行提撥經費設置外國學生獎學金、助學金。

Article 15: In order to provide incentive awards for outstanding international students who arestudying at universities and tertiary colleges in Taiwan, the Ministry of Education may set up international student scholarships or may subsidize universities and tertiary colleges to do so.

To encourage international students to come and study in Taiwan, universities and tertiary colleges may allocate funds to set up scholarships or financial study assistance for international students.

第十六條

一.大專校院應指定專責單位或人員負責辦理外國學生就學申請、輔導、聯繫等事項,並加強安排住宿家庭及輔導外國學生學習我國語文、文化等,以增進外國學生對我國之 了解。

二. 大專校院應於每學年度不定期舉辦外國學生輔導活動或促進校園國際化,有助我國 學生與外國學生交流、互動之活動。

Article 16: Universities and tertiary colleges shall designate units or personnel to be responsible for handling international student admission applications, counseling, and liaison matters. These units or personnel shall also boost the arrangement of homestay accommodation for international students and of assistance for them to learn Mandarin Chinese and about Taiwanese culture in order to better enhance their understanding of Taiwan.

At different times each academic year, universities and tertiary colleges shall organize counseling activities for international students or accelerate campus internationalization to help to foster exchanges and interactions between local students and international students.

第二十一條

一、外國學生就學應繳之費用,依下列規定辦理:

(一)依前二條規定入學者、經駐外機構推薦來臺就學之外交部臺灣獎學金受獎學生及 具我國永久居留身分者,依就讀學校所定我國學生收費基準辦理。

(二)依教育合作協議入學者,依協議規定辦理。

(三)前二款以外之外國學生,依其就讀學校所定外國學生收費基準,並不得低於同級私立學校收費基準。

二、本辦法中華民國一百年二月一日修正施行前已入學之學生,該教育階段應繳之費 用,仍依原規定辦理。

Article 21: The tuition-related fees that international students in Taiwan shall pay are determined as stipulated below:

1. Students who have been admitted to study in Taiwan in accordance with the provisions of the previous two articles, or who have received a MOFA Taiwan Scholarship following recommendation by an overseas mission, or who have the status of permanent residents in Taiwan shall pay tuition and other fees in accordance with the standard fees that their educational institution applies to domestic students.

2. Students admitted to an educational institution in Taiwan in accordance with an education cooperation agreement shall pay their tuition and other fees as specified in the agreement.

3. If an international student is not covered by the provisions of either of the preceding two subparagraphs, an educational institution may charge the student based on the standard tuition and other fees for international students that it has determined, and these are not permitted to be lower than the fees levied by other private educational institutions at the same level.

A student who was admitted to an educational institution in Taiwan before the date of effect of the February 01, 2011 amendment to these regulations shall pay tuition and other fees for this stage of education in accordance with the pre-amendment provisions.

第二十二條

一、外國學生註冊時,新生應檢附已投保自入境當日起至少六個月效期之醫療及傷害 保險,在校生應檢附我國全民健康保險等相關保險證明文件。

二、前項保險證明如為國外所核發者,應經駐外機構驗證。

Article 22: When a new international student registers, they shall submit proof of being covered by a medical and injury insurance policy that is valid for at least six months from the date that they entered Taiwan. Current students shall present documentary proof that they have joined Taiwan's National Health Insurance Plan.

If the proof of insurance referred to in the previous paragraph was issued in a foreign country, it shall be authenticated by an overseas mission.

第二十三條 外國學生有違反就業服務法之規定經查證屬實者,學校或相關主管機關應 即依規定處理。

Article 23: If an investigation verifies that an international student has violated the provisions of the Employment Services Act, their educational institution, or the appropriate competent authority shall immediately handle the matter in accordance with the regulations.

第二十四條 外國學生有休學、退學或變更、喪失學生身分等情事,學校應通報外交部 領事事務局及學校所在地之內政部移民署各服務站,並副知本部。

Article 24: If an international student defers or abandons their studies, or if there is any change to or loss of their student status, their educational institution shall notify the Bureau of Consular Affairs of the Ministry of Foreign Affairs, the service center(s) of the National Immigration Agency of the Ministry of the Interior where their educational institution is located, and send copies of these notifications to the Ministry of Education.

第二十五條

一、主管教育行政機關得視需要對招收外國學生之學校辦理訪視,學校違反本辦法規 定者,依相關法令規定處理。

二、學校未依第二十三條規定處理者,各該主管教育行政機關並得視情形調整招收外 國學生名額。

Article 25: If it is considered necessary, the competent education administration authority may visit educational institutions that admit international students. Any institution found in violation of the provisions of these regulations shall be dealt with in accordance with the provisions of the applicable laws and regulations.

If an educational institution is not acting in accordance with the provisions of Article 23, depending on the circumstances, the appropriate competent education administration authority may also adjust the international student enrollment quotas for that educational institution.

第二十八條 一、本辦法自中華民國一百零一年八月一日施行。 二、本辦法修正條文,除中華民國一百零一年十二月二十四日修正發布之條文,自一 百零二年一月一日施行,一百零二年八月二十三日修正發布之條文,自一百零二年九月 一日施行外,自發布日施行。

Article 28: These regulations shall take effect on August 1, 2012.

The amendments to these regulations shall take effect on the date of promulgation, with the exception of the amendments promulgated on December 24, 2012, which shall take effect on January 1, 2013, and the amendments promulgated on August 23,2013, which shall take effect on September 1, 2013.

## 3. 中華大學國際專修部學生修業辨法 Academic Regulations of International Foundation Program, Chung Hua University

第一條 本校國際專修部依據教育部「重點產業領域擴大招收僑生港澳學生及外國學生 實施計畫」招收境外學生,為規範學生學雜費、課程銜接,特訂定本辦法。

Article 1: The International Foundation Program of our school recruits overseas students in accordance with the Ministry of Education's "Implementation Plan for Expanding the Recruitment of Overseas Students, Hong Kong, Macao, and Foreign Students in Key Industries.". In order to regulate students' tuition fees and course connections, this regulation has been specially formulated.

第二條入學資格:

Article 2: Admission Requirements:

一、符合「外國學生來臺就學辦法」、「香港澳門居民來臺就學辦法」及「僑生回國 就學及輔導辦法」所定外國學生、港澳生及僑生身份,且具學士班入學資格。

二、申請來臺於國際專修部先修華語每人以一次為限,遇特殊事由中斷,經教育部同 意後,得再申請一次。

1. The applicant must meet the requirements of the "Regulations on the Study of Foreign Students in Taiwan," the "Regulations on the Study of Hong Kong and Macao Residents in Taiwan," and the "Regulations on the Study of Overseas Chinese Students in Taiwan.". Students who are foreign students, students from Hong Kong and Macao, or overseas Chinese as defined in the "Study and Guidance Regulations" and have the qualifications to enroll in undergraduate programs.

2. Each person may apply to come to Taiwan to study Chinese at the International Foundation Program only once. If there are special reasons for interruption, the applicant may apply again with the approval of the Ministry of Education.

第三條入學審查:

Article 3: Admissions Review:

一、申請者通過審查資格後,由教務處發給國際專修部華語先修生(以下稱先修生)入學許可,並將錄取名冊函報教育部,由教育部函轉外交部領事事務局轉知各駐外館處。

二、學先修生所繳入學證明文件如有偽造、假借、塗改等情事,如經查明,應撤銷錄 取資格;已註冊入學者,撤銷其學籍,且不發給任何相關學業證明;如畢業後始發現者, 由本校撤銷其畢業資格並註銷其學位證書。

1. After the applicant passes the qualification review, the Office of Academic Affairs will issue an admission permit to the International Foundation Program Chinese Preparatory Students (hereinafter referred to as Preparatory Students) and report the admission list to the Ministry of Education, which will then forward it to the Ministry of Foreign Affairs' Consular Affairs Bureau to inform all overseas missions.

2. Prerequisites if the admission documents submitted by the prerequisite students are forged, borrowed, or altered, if found, their admission qualifications shall be revoked; if they have already registered, their student status will be revoked, and no relevant academic certificates will be issued; if discovered after graduation, their graduation qualifications will be revoked by the school, and their degree certificates will be cancelled.

第四條 修課規範:

Article 4: Course Specifications:

一、研修期間以一年為限,期間限修讀華語課程,亦不開放暑修:學期間每週至少20 小時,全學年共修讀720小時。依第二條第二款重新申請入學國際專修部後,其修業規範依 據本辦法須重新修讀滿720小時,前期修讀之時數不予認列。

1. The training period is limited to one year, during which only Chinese courses can be taken, and summer study is not allowed: at least 20 hours per week during the semester and a total of 720 hours of study in the entire school year. After reapplying for admission to the International Foundation Program Studies in accordance with Article 2, Paragraph 2, the student must restudy for 720 hours in accordance with these regulations, and the hours studied in the previous period will not be recognized.

二、學生學業成績考評,包含平時成績、期中成績與期末成績;成績評量標準、方式 由任課教師依課程實際需要而實施採行,並公布於課程內容。

2. Assessment of academic performance of prerequisite students, including attendence grades, midterm grades and final grades; performance evaluation standards and methods shall be implemented and adopted by the teachers according to the actual needs of the course, and shall be published in the course content.

三、學生各項成績經教師評定後送交國際專修部,不得更改。但如屬教師之失誤有遺 漏或核算錯誤者,由任課教師將「學生成績更正申請表」暨相關資料備妥,以書面送交國 際專修部更改成績,最遲於下一學期開學後一週內提出。

3. All grades of prerequisite students shall be submitted to the International Foundation Program after being evaluated by the teacher and shall not be changed. However, if there is an omission or calculation error due to the teacher's mistake, the teacher in charge shall prepare the "Student Grade Correction Application Form" and relevant information and submit them in writing to the International Foundation Program to correct the grades. The latest submission shall be made within one week after the start of the next semester.

4.學生符合下列情形之一者,准予補考:

Students who meet one of the following circumstances will be allowed to take a make-up exam:

(一)期中及期末考試期間,因病住院(須檢具醫院證明)經請假核准者。

(二)期中及期末考試期間,因喪假、公假(須檢具有關證明)或不可抗拒事故無法參加考 試者。。

不符合上述二項條件者,不予補考,學期學業補考與成績計算應依「中華大學學生請 假規則」第四條規定辦理之。

(1) Those who are hospitalized due to illness during the mid-term and final exams (a hospital certificate is required) and have been approved for leave.

(2) Those who are unable to take the exam during the midterm and final exams due to bereavement leave, public holidays (relevant certificates are required), or force majeure.

Students who do not meet either of the above two circumstances will not be allowed to take make-up exams. Make-up exams and grade calculations for the semester should be handled in accordance with Article 4 of the "Regulations on Leave of Absence for Students of Chung Hua University.".

五、學生於考試時有作弊行為者,經查證屬實,除該科目該次考試成績以零分計算外, 並視情節輕重依據學生獎懲實施辦法予以處分。

5. If a student cheats during an exam and is found guilty, in addition to receiving a zero score for that subject, the student will be punished according to the Student Awards and Punishment Implementation Measures depending on the severity of the case.

六、學生因故缺席,得依照學生請假辦法請假,未經請假或請假未准而缺席者視為曠課。

6. Prerequisite students who are absent for any reason may apply for leave according to the student leave policy. Absence without applying for leave or whose leave is not approved will be considered as absence.

七、學生某一科目缺(曠)課時數達全學期該科授課總時數三分之一者,不得參加該科期 末考試,該科期末成績以零分計,平時與期中成績保留計算。

7. If a prerequisite student misses one-third of the total class hours for a certain course in the entire semester, he/she will not be allowed to take the final examination for that course. The final grade for that course will be counted as zero, and the attendance and midterm grades will be retained for calculation.

八、學生於修讀一學年之華語課程後,應考取華語文能力測驗(TOCFL)之聽力與閱讀 測驗基礎級 A2 標準(含以上),得接續修讀所屬之學系之一年級課程;未達標準者,採退學 處分。

8. After completing one year of Chinese language courses, prerequisite students must pass the listening and reading test of the Test of Competence in Chinese Language (TOCFL) at the basic level A2 (or above) to continue studying the first-year courses of the department to which they belong. Those who fail to meet the standards will be expelled.

九、學生於國際專修部修讀一年並通過華語文能力測驗(TOCFL)之聽力與閱讀測驗基礎級 A2 檢測後,必須就讀原錄取之學系,無法配合者需辦理退學,不得續留國際專修部, 國際專修部應通報內政部移民署各服務站、外交部領事事務局並副知教育部。

9. After completing one year of study at the International Foundation Program and passing the A2 test in the listening and reading comprehension section of the Test of Competence in Chinese (TOCFL), prerequisite students must study in the department to which they were originally admitted. Those who are unable to cooperate must withdraw from the program and are not allowed to continue to stay at the International Foundation Program. The International Foundation Program should notify all service stations of the Agency of the Interior, the Bureau of Consular Affairs of the Ministry of Foreign Affairs, and notify the Ministry of Education as well.

十、學生華語課程研修期間不得轉系或轉學、亦不得休學;但於正式修讀學士班課程 一年後,得申請轉系或轉學,申請轉系或轉學之學系,限符合教育部規範之製造業、營造 業、農業及長期照顧業等相關系所。 10. Prerequisite students are not allowed to change departments or schools during the Chinese language courses, nor are they allowed to take a leave of absence; however, they may apply to transfer departments or schools after one year of formal study in the bachelor's program. The departments to which they apply to transfer are limited to those that comply with the Ministry of Education's regulations. Manufacturing, construction, agriculture, long-term care and other related establishments.

第五條 工作許可:工作許可:學生於修業期間得比照一般學位生向勞動部申請工作許可,並確保學生工讀符合法令規定「學期期間工讀限20小時/週;寒暑假不限」。

Article 5: Work Permit: During the period of study, students can apply for a work permit from the Ministry of Labor in the same way as general degree students and ensure that students' work-study complies with the legal provisions. "Work time is limited to 20 hours/week during the semester; there is no limit on winter and summer vacations."

第六條 學雜費收費標準及期程:

Article 6: Tuition and Fee Standards and schedule:

一、111學年度及113學年度第1學期入學之學生,於國際專修部研習期間需繳交3萬 元華語先修學費,另住宿費及各項代收費用依規定辦理;進入學系大一課程就讀後依所屬 學系繳交學雜費。

二、113學年度第2學期起入學之學生,於就讀期間第1學期免繳學雜費,第2學期繳 交學雜費45,121元,第3學期進入學系後須依各系收費標準繳交學雜費,另住宿費及各項代 收費用依規定辦理。

三、學生休退學及退費標準依據一般學籍生規定時程辦理,未依規定完成學費繳費者 依學則處理。

四、學雜費得申請分三期繳款。繳款期程為每年2、3、4月20日及9、10、11月20日。 每期可提早繳款,但不得延期繳費,若違反規定者依學則規定處理。

五、學生須於每學期開學日前繳納各項代收費及住宿費用,使得申請新學期學雜費分 期繳納。

1. Prerequisite students who enroll in the first semester of the 2022 academic year and the 2024 academic year are required to pay NTD 30,000 in Chinese language prerequisite tuition during their studies in the International Foundation Program Studies. In addition, accommodation fees and various agency fees will be handled in accordance with regulations when entering the department. After enrolling in a course, you must pay tuition and miscellaneous fees according to the department you belong to.

2. Students who enroll from the second semester of the 2024 academic year are exempted from paying tuition and miscellaneous fees in the first semester. In the second semester, they must pay tuition and miscellaneous fees of NTD 45,121. From semester 3, they must pay tuition and miscellaneous fees according to the fee standards of each department and provide separate accommodation. Fees and various agency fees shall be handled in accordance with regulations.

3. Students' withdrawal and tuition refund standards will be handled according to the timetable prescribed for students with general student status. Those who fail to complete tuition payment in accordance with regulations will be handled according to academic regulations.

4. Tuition and miscellaneous fees must be paid in three installments. The payment periods are February, March, April 20th, and September, October, and November 20th of each year. Payment can be made in advance for each period, but payment cannot be delayed. Anyone who violates the regulations will be dealt with according to the academic regulations.

5. Students must pay all fees and accommodation fees before the start of each semester to apply for installment payment of tuition and miscellaneous fees for the new semester.

第七條 學雜費減免之資格:

Article 7: Eligibility for tuition and miscellaneous fee exemptions:

113學年度第2學期起入學之學生於就讀期間,當學期出席率達90%以上及學業成績平均70分以上,下學期學雜費得減免20%。

Students who enroll from the second semester of the 2024 academic year and have an attendance rate of more than 90% and an average academic score of more than 70 during the semester will be entitled to a 20% reduction in tuition and miscellaneous fees for the next semester.

第八條 新生註冊時應檢附已投保自入境當日起至少六個月效期之醫療及傷害保險, 前 項保險證明如為國外所核發者,應經駐外館處驗證。

Article 8: When registering as a new student in prerequisite studies, the new student must attach medical and injury insurance that is valid for at least six months from the date of entry. If the insurance certificate mentioned in the preceding paragraph is issued by a foreign country, it should be verified by the overseas embassy office.

第九條 本辦法如有未盡事宜,依本校其他相關法規辦理。

Article 9: If there are any matters not covered in these regulations, they will be handled in accordance with other relevant laws and regulations of the school.

第十條 本辦法經行政會議通過,校長核定後公告後實施,修正時亦同。

Article 10: These regulations will be implemented after being approved by the administrative conference, approved by the principal, and announced as amendments.

## 4. 國際專修部獎學金暨學雜費減免辦法

## International Foundation Program Studies Scholarship and Tuition and Miscellaneous Fee Waiver Measures Tuition and fees exemption

第一條為鼓勵本校國際專修部學生精進華語文及專業課程之學習,特訂定國際專修部 獎學金暨學雜費減免辦法(以下簡稱本辦法)。

Article 1: In order to encourage Chinese language preparatory students (hereinafter referred to as students) in the International Foundation Program Studies of our school to improve their study of Chinese language and professional courses, the scholarship and tuition and miscellaneous fee exemption measures for the International Foundation Program Studies (hereinafter referred to as these measures) are specially formulated.

第二條本辦法適用對象及期間:

Article 2: Applicable objects and period of this measure:

本辦法適用於113學年度第2學期起入學之學生。於國際專修部就讀期間第1學期免繳 學雜費,第2學期繳交學雜費45,121元,第3學期進入學系後則依各系收費標準繳交學雜 費。

This measure applies to students enrolling in the second semester of the 2024 academic year. During the first semester of studying in the International Foundation Program Studies, tuition and miscellaneous fees are exempt. In the second semester, tuition and miscellaneous fees are NTD 45,121. From the third semester, tuition and miscellaneous fees are paid according to the charging standards of each department.

第三條本辦法補助資格及申請流程:

Article 3: Eligibility and application process for subsidies under this measure:

一、學生於就讀期間,當學期出席率達90%以上及學業成績平均70分以上,下學期學 雜費得減免20%。符合資格之學生,每學期末由國際專修部學務組公告周知。

1. If a student has an attendance rate of over 90% and an average academic performance of over 70 during the semester, the tuition and fees for the next semester will be reduced by 20%. Qualified students will be notified by the Division of Student Affairs of the International Foundation Program Studies at the end of each semester.

二、學生於進入學系升大二前通過華語文能力測驗(TOCFL)之聽力與閱讀測驗進階級 (B1)以上,得申請 5,000 元獎學金,符合資格之學生須於第 5 學期開學日十五天前,且完成 註冊手續後,檢附相關華語能力測驗之相關證明,向國際專修部學務組提出申請,逾時視 同放棄,不得提出異議。

2. Students who pass the listening and reading tests of the Test of Chinese Language Proficiency (TOCFL) and advance to level (B1) (inclusive) before entering the sophomore year can apply for a scholarship of NTD 5,000. Qualified students must enter the fifth semester. Fifteen days before the start of the fifth semester, submit the application to the Division of Student Affairs of the International Foundation Program Studies with relevant certificates of the relevant Chinese language proficiency test. Failure to do so will be deemed to be a waiver, and no objection will be raised.

第四條第四條本獎學金由國際專修部會議審核通過後始得領取。若經查受獎資格有偽 造或不實之情事,則撤銷其受獎資格,並依校規處理。

Article 4: This scholarship can only be received after it is reviewed and approved by the International Foundation Program meeting. If the certificate is found to be forged or untrue, the award qualification will be revoked. If the scholarship has been awarded, it will be recovered and returned to the school in accordance with the law.

第五條113學年度第2學期起入學之學生,不適用國際專修部獎學金補助辦法(文件編號: AS2-3-003)。

Article 5: Students enrolling from the second semester of the 2024 academic year are not eligible for the scholarship subsidy regulations of the Department of International Foundation Program (Document Number: AS2-3-003).
